Dear Duniway Parents and Friends,

August 2009

We close this school year with a total of \$164,432 raised through our annual campaign, auction and other fundraising events. As you know, these funds help to offer enrichment teaching positions – music, library, physical education and literacy support – that next year's students otherwise wouldn't enjoy.

All of us on the Foundation board are so grateful to you – the parents, grandparents, and friends who, year after year, show support and compassion for Duniway. The time and money that you pour into the Foundation testify to an absolute commitment to the highest quality education for our kids. Your generosity extends to kids district-wide through our contributions to the Portland Schools Foundation's grant programs.

This was a particularly unsettling year for school funding, as the state and district saw tremendous budget pressure, and many families experienced their own financial stresses. Nonetheless, you stepped up and at the time of this writing you had given on par with last year. Thank you!

Despite this, we find ourselves in a situation – for the second consecutive year – in which giving has been outstripped by the cost of funding our enrichment teaching positions, and this is not sustainable long-term. As we look ahead to next year, we pledge to redouble our efforts to find a maintainable level of resources. The good news is that we will see only a small decrease in funded "enrichment" positions at Duniway. When faced with a cut to our music program, the PTA voted to fund an additional day of music out of its reserves. As a result, for the 2009-2010 school year, music will be offered four days a week instead of the budgeted three days a week. What a tremendous school community we have!

Please remember that as an all-volunteer board, we are here to serve on your behalf. Our meetings are held in the school library the first Monday of each month and we encourage you to attend, share your insights and let your voice be heard.

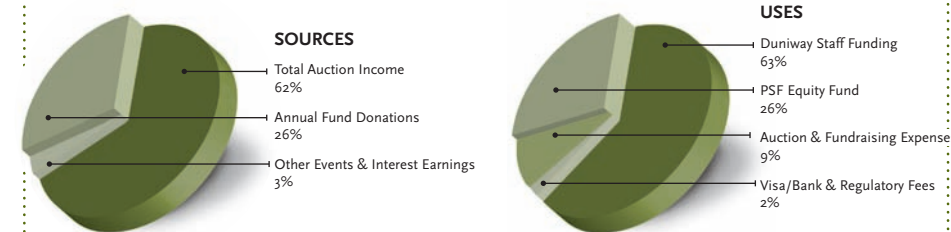
It is a privilege to work with such a dedicated community and above all to witness the tangible results of our efforts in the smiles and stories that our kids bring home every day.
