Dear Duniway Parents and Friends,

September 2, 2010

Thanks to your hard work and generosity, the Duniway School Foundation closes another successful year, with a total of \$178,873 raised through our Annual Fund Campaign, the annual auction, and other fundraising efforts. Our outstanding parent community has once again raised enough money to fund vital faculty positions that might otherwise be cut.

As you know, Portland's public schools have felt the pressures of yet another round of funding cuts. Duniway was not excluded from cutbacks in district funding. However, we are happy to report that the enrichment staffing positions for the coming 2010-2011 school year remain largely intact. Thanks to your support, we will continue to have full-time physical education, music at 0.8 of full time, and library support at 31 hours per week. Our minimally funded literacy position in 2009-2010 (two hours per day) will be eliminated. Unfortunately, other schools in the district will face deeper, more painful losses.

Whatever budget challenges come next, we members of the all-volunteer Foundation board will be ready to work on your behalf to support your priorities. We look forward to working with you in 2010-2011 and beyond to keep enrichment programs alive at Duniway and to ensure that Duniway retains the academic diversity and vitality that help make it a special place.

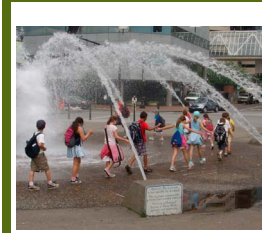

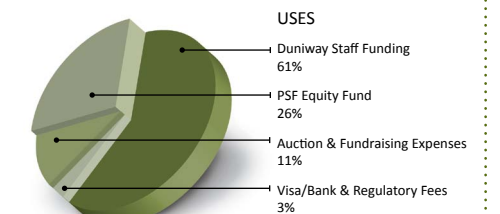
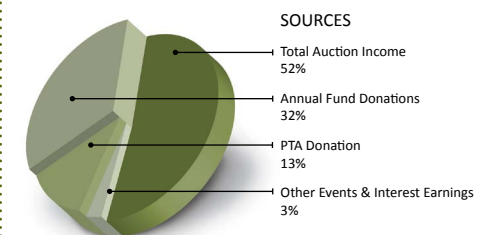

Truly, we have much to look forward to. Thank you for all you do for Duniway.

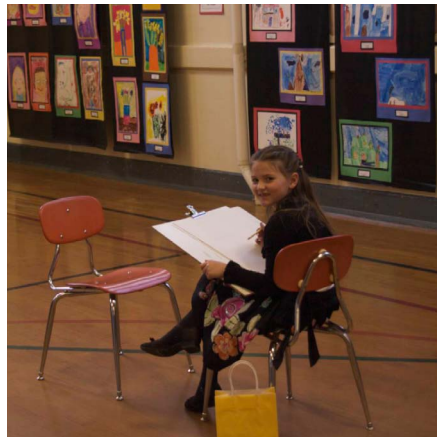
