Dear Duniway Parents and Friends,

October 2011

The ups and downs of the school funding outlook last year seem distant as the new school year begins. Remember the sense of impending doom last year? Remember the relief when the Portland Public Schools local option levy passed in May? Many of you asked me in the weeks following the election whether the dollars raised by the Foundation were still necessary to support Duniway's current level of staffing. The answer: Absolutely!

The levy saved Portland Public Schools from having to make the staffing cuts that have beset many other school districts throughout the state, and I feel grateful to Portland voters for having the wisdom to pass that measure. Even so, as we move forward into another school year, it's important to remember that the levy mostly allows us hold our ground. Every dollar you helped raise through the Foundation last year was vital in supporting Duniway staffing levels for 2011-2012, and the mission of the Foundation to raise money for Duniway staffing positions is as crucial as ever.

Thanks to the hard work and generosity of many devoted parents and supporters, the Foundation raised \$189,435 during 2010-2011, which allowed us to fund 1.73 full-time faculty positions for the 2011-2012 school year. That's a spectacular achievement, especially during hard economic times. Thanks to all of you who helped make it happen!

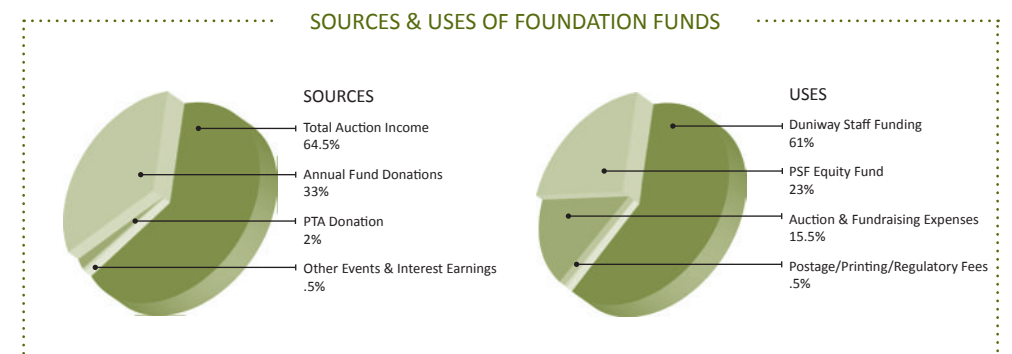
Together with funding from the levy and some hard work by Principal Sara Hahn, dollars raised through the Foundation actually helped Duniway regain some staffing lost the previous year: Duniway regained a reading support specialist staffed 10 hours a week. Our children continue to benefit from full-time physical education, music at 0.8 of full time, and library support at 31 hours per week. And class sizes are generally down.

As we close out last year and begin another year of fundraising, the all-volunteer board members of the Duniway School Foundation invite each and every one of you to help in whatever way you can. Duniway is stronger for each parent who takes that first big step to get involved, whether that means volunteering in the classroom, volunteering with the PTA or Foundation, and/or writing a check.

Best wishes for a fabulous 2011-2012 school year.
